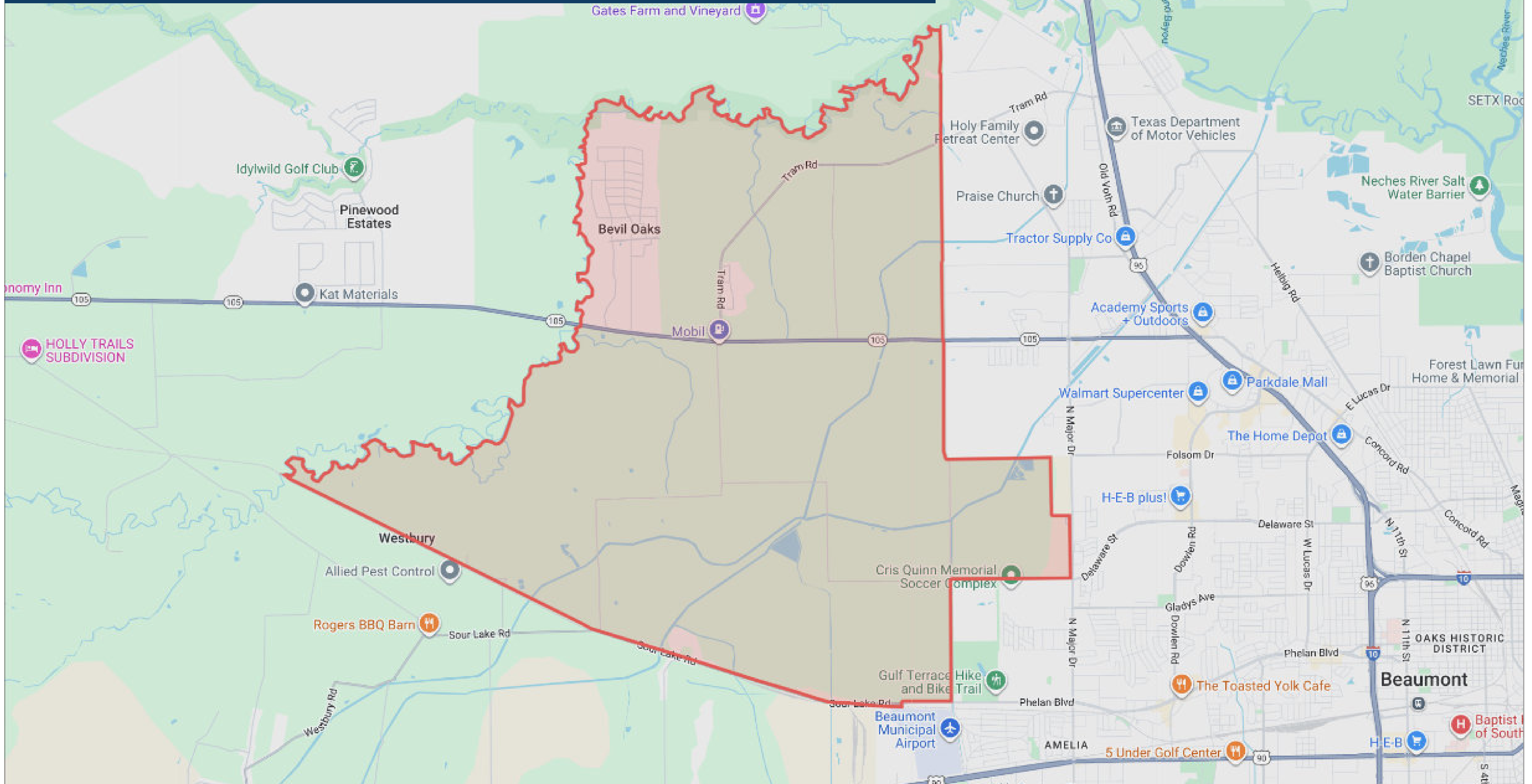

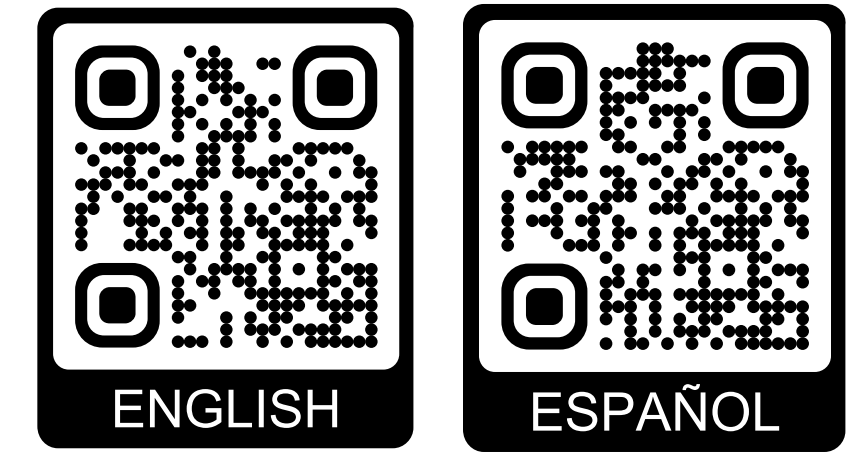
JEFFERSON COUNTY EMERGENCY SERVICE DISTRICT NO. 1

Ballot Language



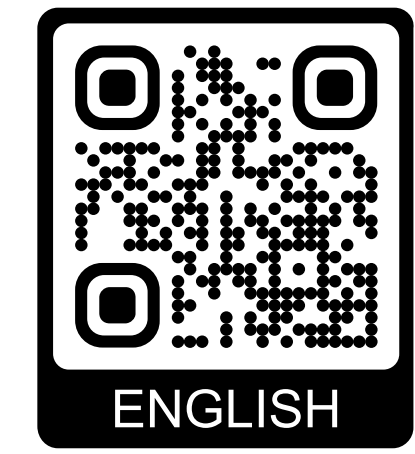
The November 4, 2025 ballot will ask residents of the district to vote for or against a Local Sales and Use Tax for the entity known as Jefferson County Emergency Services District No. 1. It will read as follows:

Proposition A:

THIS IS A TAX INCREASE. THE ADOPTION OF AN INCREASED LOCAL SALES AND USE TAX IN JEFFERSON COUNTY EMERGENCY SERVICES DISTRICT NO. 1 AT A RATE NOT TO EXCEED ONE AND ONE-HALF PERCENT (1.5%) IN ANY LOCATION IN THE DISTRICT.

Voters will need to be looking for this language if they wish to cast their vote regarding the sales and use tax for JCESD 1.

District Strategic Plan



Through sound fiscal management and good stewardship, the Board of Commissioners of JCESD No. 1 has been able to purchase and maintain equipment and apparatus (i.e., fire trucks and response vehicles) needed to protect the community, while also providing training, hiring off-duty firefighters on a limited scale, and establishing and managing a capital reserve account for scheduled long-term expenditures. However, there are three (3) major issues facing the District that require additional funding are as follows:

- Hire additional certified firefighters to provide full-time staffing at the District's fire station
- Purchase additional equipment, including PPE (Personal Protective Equipment) and emergency response vehicles, to ensure firefighter readiness and safety
- Acquire property to build a more centrally located fire station

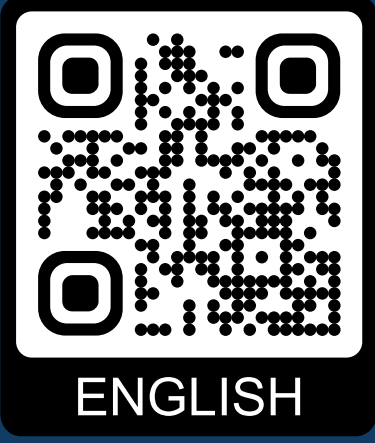
