MINUTES OF THE REGULAR MEETING OF THE BOARD OF COMMISSIONERS OF THE JEFFERSON COUNTY EMERGENCY SERVICES DISTRICT NO. 1

A Public Hearing and Regular Meeting of the Board of Commissioners of the Jefferson County Emergency Services District No. 1 ("District") was called at 6:00 p.m. on the 20nd day of December 2021, at the 13550 River Oaks Blvd., Beaumont, Texas 77713, pursuant to notice duly posted according to law.

Members of the public were invited to attend and participate in meeting by conference call. A recording of the meeting is available upon request.

The roll was called of the Commissioner on the Board, to-wit:

At 6:12 p.m., President Johnson announced that a quorum was established, and then called on Commissioner Simmons to lead the group in prayer and the Pledge of Allegiance.

Agenda Item No. 4. Swear in Commissioners.

Thereafter, President Johnson asked Attorney Oxford to swear in Commissioners Barnett and Simmons. Attorney Oxford then issued the Oath of Office and asked the Commissioner to execute the oaths as well as the Statement of Office. (See Exhibit "A-1" and "A-2"). Moreover, Commissioner Zambardino

was scheduled to be sworn in but because of his absence, Attorney Oxford stated that he would arrange for Commissioner Zambardino to take the oath and execute the documents following the meeting. (See Exhibit "A-3"). Afterwards, Attorney Oxford stated that he would send all documents to the County for filing with the County Clerk.

Agenda Item No. 5. Public Comment

The President then asked for public comment but there was none.

Agenda Item No. 6 – Approve Prior Minutes

Turning to Agenda Item No. 5, to review and approval of the November 22, 2021, the President requested that the Commissioners review the minutes of the November 22, 2021 Regular Meeting and asked if there were any changes. In response, Staff and Attorney Oxford advised the Commissioners that staff reviewed the minutes prior to the meeting and only had a handful of changes.

There being no additional change, a motion was made by Commissioner Brett Weldy, which was seconded by Commissioner Robert Barnett and the unanimous vote of all the Commissioners present, to approve the minutes as presented of the November 22, 2021 Regular Meeting.

Agenda Item No. 7 - Review and approve and take-action, if necessary, on approving financial statement; authorize payment of invoices; and amending the budget.

In light of Mr. Ring's absence, the Chief presented the District's financials. The Chief started the financial reports for the month of November 2021 with a review of the District's and the Department's accounts. According to Chief, at the beginning of the November 2021, the District had \$123,229.86 in its Wells Fargo Account and \$80,883.50 in the Community Bank checking account. During November 2021, in its Wells Fargo checking account, the District received an interest payment of \$9.72 but had debits of (\$133.01) for bank services charges and (\$123,096.85) in withdraws to close the account and transfer the balance of funds to Allegiance Bank. After taking into consideration the debits and credits, the ending balance in the District's Wells Fargo checking account for November 2021 was the

interest deposited of \$9.72. Meanwhile, in the District's Community Bank checking account, there were credits for \$4,626.83 in tax revenues and \$18,239.37 in grant revenues received but debits for the monthly expenses in the amount of (\$11,752.90), leaving an ending balance for the month of \$91,996.80. (See Exhibit "B-1").

The Chief then turned to the District's savings account at Wells Fargo Bank and informed the Commissioners that the District received an interest payment of \$2.17 in the month of November but, like the Wells Fargo checking account, the District withdrew the balance of funds in the account (i.e., \$27,509.65) and transferred the funds to Allegiance Bank to close the Wells Fargo savings account. After the withdraw, there remained \$2.17 in the account. (See Exhibit "B-1").

The last District account reviewed was the new savings account at Allegiance Bank. After receiving the balance of funds in the District's Wells Fargo checking account and savings account, the opening balance in the Allegiance Bank savings account was \$150,606.50.

Next, the Chief then presented the Department's bank balances at Community Bank for November 2021. According to the Chief, the Department's checking account and savings account remained the same at \$10,000.00 for the checking account and the savings account increased by \$400.00, after the receipt of a donation, to 16,301.02 in the savings account. (See Exhibit "B-2").

After reviewing the summary of accounts, the Chief presented the District's outstanding invoice to be paid and approved at the current meeting. Per the Chief, the total expenses to be paid were \$8,302.58. (See Exhibit "B-3"). A list of the invoices paid, or to be paid, is set forth below.

Subsequently, Commissioner Hoyt Simmons made a motion to approve the 1) November 2021 account reports for the District and the Department; 2) invoices for the month of November 2021; and 3) November 2021 financial reports. (See Exhibits "B-1", "B-2", and "B-3). This motion was seconded by Commissioner Brett Weldy and unanimously approved by all Commissioners present.

Agenda Item No. 8 - Discuss and take-action, if necessary, on matters involving: 1) staffing; 2) purchase and/or 3) repair requests submitted by the Volunteer Fire Department.

No action was taken on this agenda item as purchases of equipment were going to be discussed during Agenda Item No. 8.

Agenda Item No. 9 - Discuss and take-action, if necessary, on applying for grants and/or accepting grants.

The Chief reported that he has submitted the Assistance to Firefighter grant for a new engine. The grant request was for \$375,000.00. Otherwise, no action was taken.

Agenda Item No. 10 - Review, discuss and take-action, if necessary, on authorizing staff and General Counsel to:

- Prepare and file end of the year report with the State; and
- Post Notice of address.

Attorney Oxford presented the Commissioners with a proposed Notice of Address that the District is required to post each January and asked for authority to publish the notice. (See Exhibit "C"). In addition, he explained that the Annual Report for 2022 had not been posted yet but once it was posted, he requested permission to complete the report and file it.

The Commissioners reviewed the proposed Notice of Address and thereafter, Commissioner Hoyt Simmons made a motion to authorize staff to publish the Notice of Address and authorized Attorney Oxford to complete and file the annual Emergency Service District report after the 2022 report was published. This motion was seconded by Commissioner Robert Barnett and unanimously approved by all Commissioners present.

Agenda Item No. 11 – Discuss and take-action, if necessary, on adopting an Investment Policy.

The Commissioners were then presented with Annual Investment Policy and asked to review it. (See Exhibit "D"). According to Attorney Oxford, the policy as presented was similar to the prior policy adopted, with the exception of the dates, but needed to be re-adopted each year.

After a review of the policy, Commissioner Robert Barnett made a motion to adopt the Investment Policy as set forth in **Exhibit "D"**. This motion was seconded by Commissioner Brett Weldy and unanimously approved by all Commissioners present.

Agenda Item No. 12 - Chief's Report

According to the Chief, in November 2021, the Department and the District's firefighters responded to twelve (12) calls. He then gave the Commissioners highlights of various calls set forth below.
