

No formal action, discussion, deliberation, nor comment will be made by the Board of Commissioners.

 - July 26, 2021 Regular Meeting.
6. Review and approve and take-action, if necessary, on approving financial statement; authorize payment of invoices; and amending the budget.

7. Discuss and take-action, if necessary, on designating funds in savings accounts for capital purchases.
8. Discuss and take-action, if necessary, authorizing the execution and filing of ad valorem forms for the Jefferson County Tax Assessor's Office and/or the Jefferson County Appraisal District's Office.
