OF JEFFERSON COUNTY EMERGENCY SERVICES DISTRICT NO. 1**



In accordance with the Texas Attorney General's opinion, any public comment that is made on an item that is not on the published final agenda will only be heard by the Board of Commissioners. No formal action, discussion, deliberation, nor comment will be made by the Board of Commissioners.
5. Discuss and take-action, if necessary, on approving the minutes from the March 27, 2023 Regular Meeting.
6. Review and approve and take-action, if necessary, on approving financial statement and approve payment of invoices for April and May 2023; and amending the budget.
7. Discuss and take-action, if necessary, on matters involving: 1) staffing; 2) purchases of real and/or person property; and/or 3) repair requests.
8. Discuss and take-action, if necessary, on needed action regarding applying and/or accepting grants.
9. Discuss and take-action, if necessary, approving agreements and/or resolutions with Steller Bank to be in compliance with Chapter 2256 and 2257 of the Government Code.
10. Discuss and take-action, if necessary, to terminate agreement with Architectural Alliance.
11. Discuss and take-action, if necessary, on authorizing the execution of an agreement to join the HGAC.

12. Discuss and take-action, if necessary to approve the disposal of surplus and salvage property.
