OF JEFFERSON COUNTY EMERGENCY SERVICES DISTRICT NO. 1**



Regular Meeting

In accordance with the Texas Attorney General's opinion, any public comment that is made on an item that is not on the published final agenda will only be heard by the Board of Commissioners. No formal action, discussion, deliberation, nor comment will be made by the Board of Commissioners.
5. Review, discuss, and approve minutes of the January 22, 2024 Regular Meeting.
6. Review and approve and take-action, if necessary, on approving financial statement; authorize payment of invoices; and amending the budget.
7. Discuss and take-action, if necessary, on matters involving: 1) staffing; 2) purchase and/or 3) repair requests submitted by the Volunteer Fire Department.
8. Discuss and take-action, if necessary, on needed action regarding applying for and/or accepting grants.
9. Discuss and take-action, if necessary, on engaging Touchstone District Services to assist with the passage of a sales tax election on behalf of the District.
10. Such other matters that may come before the board.
11. Adjourn.
