Upon adjournment of the Public Hearing, the Board of Commissioners of the Jefferson County Emergency Services District No. 1 will move into the Regular Meeting.

4. Public comment. In accordance with the Texas Attorney General’s opinion, any public comment that is made on an item that is not on the published final agenda will only be heard by the Board of Commissioners. No formal action, discussion, deliberation, nor comment will be made by the Board of Commissioners.
5. Discuss and take-action, if necessary, on appointment of officers.
6. Review, discuss, and approve minutes of the August 24, 2024 Regular Meeting.
7. Review and approve and take-action, if necessary, on approving financial statement; authorize payment of invoices; and amending the budget.
8. Review, discuss and take action to adopt the District’s fiscal year 2024-25 budget.

9. Discuss and take action to set the District's 2024 ad valorem tax rate and discuss submittal of information/materials to the Jefferson County Tax Assessor-Collector regarding same and posting of the required notices concerning the adopted tax rate on the District's website.
10. Discuss and take-action, if necessary, on matters involving: 1) staffing; 2) purchase and/or 3) repair requests submitted by the Volunteer Fire Department.
11. Discuss and take-action, if necessary, on needed action regarding applying for and/or accepting grants.
12. Chief's Report
13. Such other matters that may come before the board.
14. Adjourn.
