

2. Determination of quorum.
3. Invocation and Pledge of Allegiance.
4. Public comment. In accordance with the Texas Attorney General's opinion, any public comment that is made on an item that is not on the published final agenda will only be heard by the Board of Commissioners. No formal action, discussion, deliberation, nor comment will be made by the Board of Commissioners.
5. Review, discuss, and approve minutes of the on July 28, 2025 Regular Meeting.
6. Review, approve and take-action, if necessary, on approving financial statement; authorize payment of invoices; and amend the budget.
7. Discuss and take-action, if necessary, on matters involving: 1) staffing; 2) purchases and/or 3) repair requests submitted by the Volunteer Fire Department; and 4) grants requests.
8. Discuss and take-action, if necessary, to accept and approve the District's 2025 Certified Appraisal Roll (*see* attached form Resolution) and 2025 Tax Rate Calculation Worksheet.
9. Discuss and take-action, if necessary, to review and discuss the District's fiscal year 2025-26 budget and take-action on District's *proposed* 2025-26 budget and the *proposed* 2025-26 tax rate.
