



In accordance with the Texas Attorney General's opinion, any public comment that is made on an item that is not on the published final agenda will only be heard by the Board of Commissioners. 10. Discuss and take-action, if necessary, for setting the meetings dates for 2026.
11. Discuss and take-action, if necessary, on adopting an Amended and Restated Service Agreement with the Department.
12. Discuss and take-action, if necessary, on the status of Jefferson County Emergency Services District No. 1, Inc.
13. Chief's Report
14. Such other matters that may come before the board.
