



**NOTICE OF REGULAR MEETING
OF JEFFERSON COUNTY EMERGENCY SERVICES DISTRICT NO. 1**

Notice is hereby given that a Regular Meeting of the Board of Commissioners of Jefferson County Emergency Services District No. 1 (“District”) will be held on March 30, 2026, beginning at 6:00 p.m., at the District’s Administrative Office, located at 13550 River Oaks Blvd., Beaumont, Texas 77713, for the following purposes:

1. Call to order.
2. Determination of quorum.
3. Invocation and Pledge of Allegiance.
4. Public comment. In accordance with the Texas Attorney General’s opinion, any public comment that is made on an item that is not on the published final agenda will only be heard by the Board of Commissioners. No formal action, discussion, deliberation, nor comment will be made by the Board of Commissioners.
5. Review, discuss, and approve minutes of the February 23, 2026 Regular Meeting.
6. Review, approve and take-action, if necessary, on approving the February 2026 financial statements; payment of invoices; and amend the budget.
7. Discuss and take-action, if necessary, on matters involving: 1) staffing; 2) purchase; 3) repair requests submitted by the Volunteer Fire Department; and 5) grant request.
8. Discuss and take-action, on the status of Jefferson County Emergency Services District No. 1, Inc and if necessary, adopt an Amended and Restated Service Agreement with the Department.
9. Discuss and take-action, if necessary, regarding acceptance of the regulatory memorandum and authorization of all actions necessary for Jefferson County Emergency Services District No. 1 to comply with applicable Texas Commission on Fire Protection requirements, including engagement with regulators, personnel classification, appointment of a Head of Department, and implementation of required reporting, certification, and operational procedures.

11. Such other matters that may come before the board.
