**NOTICE OF REGULAR MEETING
OF JEFFERSON COUNTY EMERGENCY SERVICES DISTRICT NO. 1**

Notice is hereby given that a Regular Meeting of the Board of Commissioners of Jefferson County Emergency Services District No. 1 will be held on August 24, 2026, beginning at 6:00 p.m., at the District's Administrative Office, located at 13550 River Oaks Blvd., Beaumont, Texas 77713, for the following purposes:

Members of the public may attend and participate in the Jefferson County Emergency Services District No. 1. Regular Meeting by conference call. In addition, a recording of the meeting will be made available following the meeting. The call-in information for the meeting is set forth below:

Regular Meeting

1. Call to order.
2. Determination of quorum.
3. Invocation/Pledge of Allegiance.
4. Public comment. In accordance with the Texas Attorney General's opinion, any public comment that is made on an item that is not on the published final agenda will only be heard by the Board of Commissioners. No formal action, discussion, deliberation, nor comment will be made by the Board of Commissioners.
5. Review, discuss, and approve minutes of the July 27, 2026 Regular Meeting.
6. Review and approve and take-action, if necessary, on approving financial statement; authorize payment of invoices; and amending the budget.
7. Discuss and take-action, if necessary, on matters involving: 1) staffing; 2) purchase and/or 3) repair requests submitted by the Volunteer Fire Department; 4) grant request; and 5) regulatory matters with the Texas Commission on Fire Protection.
8. Discuss and take-action, if necessary, to appoint a Head of the Department for the Emergency Services District.
9. Review, discuss, and take action, if necessary, on the following 2026 property tax matters:
 - a. Accept and approve the District's 2026 Certified Appraisal Roll and 2026 Tax Rate Calculation Worksheet.
 - b. Approve the District's proposed FY 2026-27 budget by record vote.

- c. Approve the District's proposed 2026 property tax rate by record vote; schedule and announce the public hearing concerning the proposed 2026 property tax rate and the meeting at which the Board will vote to adopt the District's 2026 property tax rate; and authorize publication and posting of all required notices concerning the 2026 property tax rate and public hearing.
 - d. Take action on any other necessary matters relating to the District's FY 2026-27 budget and/or 2026 property tax rate, including, but not limited to, optional tax exemptions.
